#### **Dilution Rates:**

Coverage per Mix LIGHT CLEAN - Mix 100ml Product to 2 Litres water (1:20) Approx.100m2 + CLEAN - Mix 100ml Product to 1 Litres water (1:10) NORMAL Approx. 50m2 HEAVY CLEAN - Mix 100ml Product to 500ml water (1:5) Approx. 25m2

\*Coverage: The information is purely a guide line only and may differ according to the porosity and textured finish of the stone OR ceramics and site conditions.

#### APPLICATION

ALWAYS Test small area: - Determine your desired result by testing a discreet area.

Sweep, wipe or vacuum surface first to remove general soil. Apply the desired solution by mop, brush or spray onto the stone or tile. Allow product to work on soiled area for 3 to 5 minutes. Agitate solution with mop, brush or nylon pad depending on the surface texture, do not allow to dry.

Cleaning can be carried out manually or by scrubbing machine subject to the size of floor area involved. Mop or wet vacuum up dirty solution and rinse thoroughly with clean water and remove any excess residues.
