WATER REP



SOLVENT-BASED NEUTRAL WATER-REPELLENT



DESCRIPTION

Water repellent anti-saltpetre suitable for the protection of facades, prefabricated panels and natural stone exterior cladding, reconstructed stones, exposed concrete, cement and lime various type, terracotta. The product is a solution of siloxane resins in solution solvent that after drying leave the support neutral and without superficial films, breathable and non-yellowing. WATER REP prevents the absorption of rainwater and a significant decrease in penetration dust, atmospheric dirt, organic substances, molds, allowing to keep the surfaces well clean during the years, and to avoid the degradation caused by the absorption of acid rain; it has good resistance to U.V. rays. Our facade product has a life of at least five years, but there are cases where after 20 years WATER REP continues to maintain its effectiveness.

YIELD

The yield varies from 3 to 6 m² of surface with 1 L of product.

- \cdot Smooth surfaces of 6 m²/L
- \cdot Rough surfaces of 3-4 m²/L
- \cdot Concrete agglomerate of 4-5 m²/L

APPLICATION

The product can be applied by brush, roller, spray with a pump at low pressure, on well cleaned and dry surfaces, in a passage abounding and in the case of very absorbent supports with a second hand before the previous one is dry.

The product cannot stand freezing, store it in well-closed and well-protected places, at a temperature not lower than 10 °C. Always protect yourself with mask, gloves and protective clothing. Application on horizontal surfaces is not recommended.
